Duration: 3 semesters. International experience can be acquired by doing a semester, an internship or a thesis abroad. Languages of instruction: German, English

MSc International Business Development

- Preparation for a management career in internationally expanding companies (globalisation manager)
- Transfer of practice-oriented, detailed knowledge to the development of new business ideas
- Strong academic foundation and highly application-oriented

Duration: 3 semesters. International experience can be acquired by doing a semester, an internship or a thesis abroad. Languages of instruction: German, English

MA European Management Studies (Double Degree)

- Fully integrated double degree programme (ESB Business School & EM Strasbourg) for students without a background in business studies
- Studying in three languages and two countries – with integrated internship periods

- Choose between three specialisations "International Technology Management", "International Marketing and Sales" and "International Strategy and Corporate Development"

Duration: 1 year, language of instruction: English

MBA International Management Part-Time

- Flexible and part-time, in just two years, the programme prepares high potentials from technical and scientific professions for leadership roles in internationally operating companies (German and English)
- Perfectly feasible alongside employment, lectures in block modules and attendance at weekends with additional online tutorials and coaching
- Integrated international short-term exchanges: from one to three weeks for part-time and Executive MBA at partner universities

Duration: 2 years plus master thesis (part-time every 2nd to 3rd weekend) with module abroad. Languages of instruction: German, English
